This is the Fourth Quarterly Status Report of calendar year 2014 for the Los Angeles County Regional Park and Open Space District (the District). 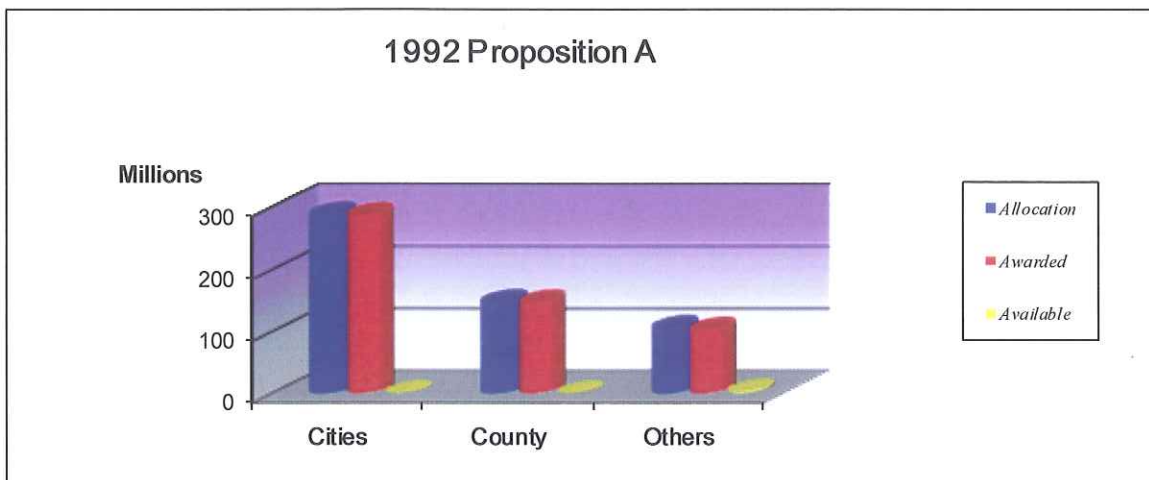

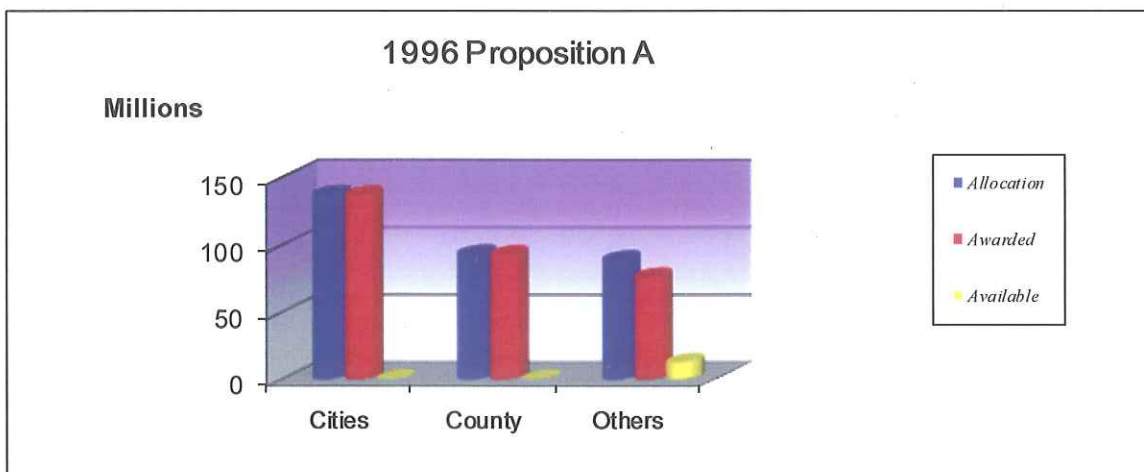
*Whittier Puente Hills At-Risk Youth Camp for \$2,500,000 was terminated on 1/7/15 increasing available funds to \$15,078,715.
